**Buyer and Seller agree as follows:**

1. A non-refundable deposit is required to hold a puppy for buyer. (Please check with seller, as different litters require different amounts for deposit.)
2. Puppy is believed to be in good health and will be up to date on vaccinations and worming by the time it is picked up by the new owner. **(See Wormer/Vaccination Record on first page.)**
3. **Health Guarantee:** For purposes of this agreement, buyer, at buyer's sole expense, may have the puppy examined by a veterinarian of buyer's choice. If the veterinarian discloses in writing which is signed by the veterinarian and provided to the seller, any problem with the health or temperament of the puppy within 72 hours of signing of this contract or receipt of puppy, buyer may be eligible to return puppy, at buyer's expense, for a partial refund of the purchase price **(puppy deposit is non-refundable)**, less any shipping expenses paid by seller. Thereafter, buyer's right to refund, as set forth in this paragraph, will terminate. Seller is not liable for any costs incurred by buyer for any treatment rendered as a result of said problem.
4. Buyer agrees to maintain puppy in good health by providing preventative health care, including, but not limited to, **vaccinations and treatment for parasites.**
5. Buyer understands and agrees to hold seller harmless from any and all claims resulting from injuries, losses and damages of any kind, including, but not limited to direct, special or consequential, which may arise out of, or result from, any act of puppy and/or buyer.
6. **Hips are guaranteed for 2 years.** If your puppy has hip dysplasia at the age of 2 you can get a partial refund or a new puppy. You will keep your dog.
7. **Parents have had DNA testing** through Embark vet and are clear of over 170+ disease that they test for. There is a 2-year guarantee against your dog having any of these diseases.
8. Do not feed dog/puppy food or treats with Corn or Corn products as the first ingredient, to your Labrador, they are not good for your dog. Read the ingredients list of all dog food before purchasing. Your dog needs meat-based protein as the first ingredient.
9. Until your puppy is fully grown it is a good idea **not** to take them for long runs especially on hard surfaces. Remember your puppy is still growing and this can cause them to have joint problems later.
10. Change your puppy to dog food if you notice that they are growing at a fast rate. This will help them to grow at a slower rate and their bones and joints will be stronger. Usually 6 months is a good time to switch to adult dog food.
11. This contract applies to the parties described herein and is not transferable to any other party.
